



# Lucky North Club Super Hot Seats

## Promotion Rules

### 1. Promotion Period:

- Super Hot Seats will run every Monday and Thursday from Monday, January 4, 2021 through Monday, March 29, 2021 during the following times:
  - 9am - 11am
  - 2pm - 4pm
  - 7pm – 9pm

### 2. Prize(s):

- Consolation Winners receive \$25 Free Play.

### 3. Public Notice:

- Lucky North Club Members who are actively playing any Video Lottery Terminal or Electronic Table Game with their Lucky North Club Player Rewards Card properly inserted in the machine qualifies to participate and may be selected as a Super Hot Seats Free Play winner between the start and end time of a Super Hot Seats Promotional Period.
