

**DELAWARE NORTH “GETAWAY GIVEAWAY” PROMOTION  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO PLAY OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. ELIGIBILITY:** The Delaware North “Getaway Giveaway” Promotion (“Promotion”) is open only to legal U.S. residents of the fifty (50) United States and the District of Columbia who are *18 years of age or older (19 years of age or older for Alabama and Nebraska residents)* at the time of participation if the individual is participating in the Promotion at *Daytona Beach Racing & Card Club (Daytona Beach, FL), Finger Lakes Gaming & Racetrack (Farmington, NY), Hamburg Gaming (Hamburg, NY), Jakes’ 58 Hotel and Casino (Islandia, NY) or Orange City Racing & Card Club (Orange City, FL).*

The Promotion is open only to legal U.S. residents of the fifty (50) United States and the District of Columbia who are *21 years of age or older* at the time of participation if the individual is participating in the Promotion at *Jumers Casino & Hotel (Rock Island, IL), Mardi Gras Casino & Resort (Cross Lanes, WV), Miami Valley Gaming (Lebanon, OH), Southland Park Gaming & Racing (West Memphis, AR) or Wheeling Island Hotel-Casino-Racetrack (Wheeling, WV).*

Employees, officers and directors of Delaware North Companies, Incorporated (“Sponsor”), its parent, subsidiary, and affiliated companies, advertising, promotion or production agencies, Web masters/suppliers, and their IRS dependents, “Participating Locations” (as defined below), immediate family members (spouse, parents, children, siblings and each of their respective spouses, regardless of where they reside), and individuals residing in their same household (whether or not related) are not eligible to participate. Additionally, any employee of or individual licensed by a state regulatory organization or body that prohibits its employees and/or licensees to participate in this Promotion and, if applicable, immediate family members and/or those living in the same household of any of the foregoing are not eligible to participate. By participating, entrants agree to these Official Rules and the decisions of Sponsor which are final and binding in all respects. Void where prohibited.

**2. PROMOTION OVERVIEW:** Between January 6, 2019 and February 9, 2019 (the “Overall Promotion Period”), the Promotion is offered to eligible individuals at these ten (10) participating locations: *Daytona Beach Racing & Card Club (Daytona Beach, FL), Finger Lakes Gaming & Racetrack (Farmington, NY), Hamburg Gaming (Hamburg, NY), Jakes’ 58 Hotel and Casino (Islandia, NY), Jumers Casino & Hotel (Rock Island, IL), Mardi Gras Casino & Resort (Cross Lanes, WV), Miami Valley Gaming (Lebanon, OH), Orange City Racing & Card Club (Orange City, FL), Southland Park Gaming & Racing (West Memphis, AR), and Wheeling Island Hotel-Casino-Racetrack (Wheeling, WV)* (each a “Participating Location”).

The Overall Promotion Period is divided into five (5) weekly entry periods (each a “Week”) as outlined in Section 4. For each Participating Location one hundred (100) Finalists will be selected in a random drawing each Week (each, a “Weekly Location Drawing”) for a total of five hundred (500) Finalists per Participating Location, as described herein. NOTE: Each Participating Location’s “Overall Promotion

Period” and “Week” vary in their starting and ending times, and while each Weekly Location Drawing will occur on a Saturday (during the Overall Promotion Period), the drawing times per Participating Location also vary. Please carefully review all details for the Participating Location in which you wish to enter. See Section 4.

During the Overall Promotion Period and for each Participating Location, eligible individuals (the “Entrants”) are invited to visit their Participating Location to obtain entry(ies) (each an “Entry”) to enter a Weekly Location Drawing. The Entrants associated with the Entries that are randomly drawn in all of the Weekly Location Drawings shall be deemed “Finalists” and will advance to the Final Drawing (defined below). There are no Finalist prizes associated with this Promotion, however Participating Locations may opt to award Participating Location prizes to Finalists. Any Participating Location Finalist prizes shall be separate from the Promotion and at the sole discretion of the Participating Location. The Entrants associated with the Finalists’ Entries that are randomly drawn in the Final Drawing shall be deemed the winners of this Promotion, as described herein.

**3. HOW TO PARTICIPATE:** A players card is required to participate in the Promotion and can be obtained for free by visiting the players club area at a Participating Location. NOTE: Each Participating Location may have a specific name associated with their players club or players card, however, for the purpose of these Official Rules, all such players clubs and players cards shall be referred to as “Players Club” or “Players Card”.

See below (Section 4) for specific details on how to obtain Entries at your Participating Location in connection with your Players Card. Entrants are allowed to obtain one (1) initial Entry for each “Daily Promotion Entry Period”\* of the Overall Promotion Period and Bonus Entry(ies) (“Bonus Entry” or “Entry”) (if offered by a particular Participating Location) for entry into a Weekly Location Drawing.

\*For the purpose of this Promotion and these Official Rules a “Daily Promotion Entry Period” shall mean the hours in which Entrants can obtain Entries for a particular day.

All Entries are printed. Lost, stolen or damaged Entries cannot be re-printed for any reason. For each Entry you obtain, save it! Lost or stolen printed Entries cannot be re-printed for any reason. Next, return to the Participating Location on any Saturday during the Overall Promotion Period, to deposit the Entry(ies) into the designated “Getaway Giveaway” drawing drum. **Entries can only be deposited into the drawing drum on Saturdays during the Overall Promotion Period (and prior to the last Weekly Location Drawing).** Entries must be deposited into the drawing drum PRIOR to a particular Weekly Location Drawing to be eligible for that drawing. For clarity, an Entrant may deposit his/her Entries into the drawing drum on ANY Saturday during the Overall Promotion Period. For example, if an Entrant obtains five (5) Entries during Week 1 and six (6) Entries during Week 2, he/she may deposit all eleven (11) Entries or a portion of them into any subsequent Weekly Location Drawing.

**4. PARTICIPATING LOCATION DETAILS:** Participating Locations are listed in alphabetical order below. Find your location for entry details.

**Applicable to all Weekly Location Drawings:**

All Weekly Location Drawings will be conducted by authorized representatives from each corresponding Participating Location whose decisions shall be final in all matters related to the Weekly Location Drawings.

Odds of being selected as a Finalist depend upon the number of eligible Entries received for a given Weekly Location Drawing. Entrants need not be present to advance to a Finalist position (i.e. be entered into the Final Drawing).

**Limit one (1) Entry per Entrant/Daily Promotion Entry Period/Participating Location (with the exception of Bonus Entries if offered by a Participating Location).** See below for your Participating Location's entry details.
